## Introduction

By 2030 our main targets are; 100% sourced from sustainable farming, reduce green house emissions by 40% and further ensure our diversity framework is fully implemented by ensuring at least 40% female employees and at least 50% in management.


### Message from our leaders

# ACCELERATE TRANSITION TO CERTIFIED GREEN ENERGY PARTNERS

Avocat Fresh will prioritize onboarding more factories and packhouses that utilize certified renewable energy sources, supporting the 2030 emissions reduction target and aligning with climate action goals.



# EU Deforestation Regulation (EUDR) Alignment

As part of our evolving sustainability framework, Avocat Fresh has initiated steps toward compliance with the EU Deforestation Regulation (EUDR). Our existing certifications (EU Organic, Rainforest Alliance), farm-to-cup traceability system, and double materiality assessments provide a strong foundation aligned with EUDR principles.

We are currently strengthening our operations to meet the specific EUDR criteria, including:

- Traceability to plot level through geolocation data collection
- Formalization of our Due Diligence System (DDS)
- Explicit zero-deforestation policy enforcement across our supply chain

These steps will ensure our products are not only legally compliant but also demonstrably deforestation-free. We remain committed to transparency, accountability, and building a future-ready, sustainable value chain.
